In November, Michael Schiavo took her to the University of California, San Francisco for experimental nerve stimulation – the Thalamic stimulator. The treatment took several months but was unsuccessful. He returned to Florida with her in January 1991 and admitted her as an inpatient to the Mediplex Rehabilitation Center in Bradenton, Florida. While there, he later said that he often took "her to parks and public places in hopes of sparking some recovery". On July 19, 1991, Terri Schiavo was transferred to the Sabal Palms Skilled Care Facility, where she received neurological testing and regular speech and occupational therapy until 1994.[13][14] In mid 1993, Michael Schiavo requested a do not resuscitate order for her after she contracted a urinary tract infection. The court appointed guardian ad litem, Jay Wolfson,[15] later wrote a report stating that Michael Schiavo's decision was "predicated on his reasoned belief that there was no longer any hope for Terri's recovery.

These types of decisions are never easy, especially for the family to make if and when a person cannot do so for him or herself. My brother that passed away back in January - he had cerebral palsy, and could not talk, eat, etc. My parents were his guardians and had to make such decisions. they met with a lawyer pretty early on in his life (he was only supposed to live to age 5 according to the doctors; he was 26 when he passed.) They decided to not have him necessitated if he ever stopped breathing, nor did they want him on a ventilator. He did have a feeding tube all his life, but that was the only way he could eat. When we was very young (until about age 5 or 6) my mom did feed him by mouth, but the process took a very long time. The food had to be blended up, mixed with some type of gravy, and it would take 3-4 tries for each individual bites for him to swallow it. It got to the point that he wasn't getting enough to grow as he should.

I dread the day I have to be in this position, either for my parents, or my husband. Actually, my hubby and I are planning to meet with a lawyer ourselves soon. We have 3 kids, ages 8, 5 and 1, and we need to take care of some stuff. We have life insurance, but we both need to do an advance directive, that way we know what each other wants, and we need to do some type of will for the kids - if we both passed, who would take them until they're adults (that's the biggie), and stuff like that. Honestly, I've put this off because I HATE thinking about it, but it needs to be done. If we don't, and something did happen to us both, then what? I can't do that do them.
